PRIMARY ELECTION INFORMATION

There will be a Gubernatorial Primary Election in June 2010. In order to vote for candidates on the ballot voters must declare a party. Currently the State of Maine recognizes 3 parties: Democratic, Green Independent and Republican.

GENERAL QUALIFICATIONS A person who meets the following requirements may vote in any election in a municipality, including a biennial municipal caucus.

- 1. Citizenship.** The person must be a citizen of the United States.
- 2. Age.** The person must be at least 18 years of age, except that, to vote in a political party's primary election or municipal caucus, the person must be at least 18 years of age as of the date of the next general election.
- 3. Residence.** The person must have established and maintain a voting residence in that municipality.
- 4. Registration.** The person must be registered to vote in that municipality.
- 5. Enrollment.** The person must be enrolled in a party in that municipality to vote at that party's caucus, convention or primary election, unless otherwise permitted by the party pursuant to section 340.

CHANGE OF ENROLLMENT

A voter may change the voter's enrollment anytime after 3 months from the date on which the voter enrolled by filing an application with the registrar personally, by mail or otherwise.



VOTING AGE QUALIFICATION FOR PRIMARY ELECTIONS

A person who has not yet reached 18 years of age but will be 18 years of age at the time of a general election and meets all other qualifications in order to vote in a primary election may vote in the primary election for the selection of candidates to be on the ballot at that general election.

PROPERTY TAX ASSISTANCE PROGRAM - 65 YEARS AND OLDER

Applications are now available at Town Hall for the Resident Property Tax Assistance Program - 65 Years and Older. There is a residency requirement of 10 years for this program and you must qualify for the Maine State Property Tax "Circuit Breaker" program. The applications must be returned to the Scarborough Tax Assessor's Office by **September 15th**.

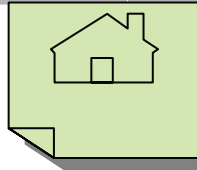

HOMESTEAD EXEMPTION

VETERANS EXEMPTION

ARE YOU RECEIVING A HOMESTEAD EXEMPTION?

To qualify property must be your primary residence, and you must have owned the property, or another residence in Maine, for the 12 months prior to April 1 of the taxable year.



DO YOU QUALIFY FOR A VETERANS EXEMPTION?

You may qualify if you served during a recognized wartime period, are age 62 or older as of April 1 of the taxable year, or are 100% service connected disabled.

2010 DOG LICENSES!

DOG LICENSES—NEW & RENEWALS

The 2010 Dog Licenses will be available after **October 15th**. Every dog in the State of Maine is required by State law to be licensed in the town in which you reside. The license period runs January 1st through December 31st and the license must be renewed each year. The fee per dog is \$6.00 for spayed or neutered dogs and \$11.00 for unaltered dogs.

The State requires proof of rabies vaccination by showing a valid Rabies Certificate and evidence of spaying or neutering, if the dog has been altered.

LATE FEES

Unfortunately as of **February 1st** there is a **State mandated** late fee of \$15.00 per dog in addition to the regular licensing fee.

So, please remember to license your dog(s) early.

CREDIT / DEBIT CARDS

Please remember that, for your convenience, we do accept credit and debit cards issued by VISA, MasterCard and Discover at Town Hall. We cannot take credit card information over the telephone; however, you can use your VISA, MasterCard or Discover Card when you come in person to Town Hall to register your vehicle, purchase licenses, obtain building permits, register for recreation programs, etc., in the following offices -



Collection Office, Community Services, Planning and Town Clerk. The Town has limited credit/debit card transactions to **\$4,000**.

You can also use a debit or credit card when you visit the State's website www.maine.gov to do a number of on-line transactions such as: renew a Driver's License or State I.D. Card, register motor vehicles, do a vanity plate search, purchase dog licenses, and use other services offered by the State of Maine.
