

## General Info At a Glance

*Temporary Signs*—are designed or intended to be used for a short period of time. Examples include:

- *Giving Public Notice (Non-commercial)*—Are permitted for a period not to exceed 20 days. These signs cannot be attached to fences, trees, utility poles or obstruct visibility.
- *Real Estate Signs*—May be erected upon the building or premises being sold. Two signs may be used depending upon the location relative to the main roadway. Unless otherwise prohibited, one generic off-premise sign (not identifying company) may be placed at the entrance of a dead-end or cul-de-sac, or one temporary “Open House” sign identifying the company may be used.
- *Temporary Development or Construction Sign*—Limited to general identification of the project may be erected on the site but must be removed within 30-days of completion of the project.
- *Temporary Business Signs*—May be used for special occasions or events, no more than 4-times in a calendar year (a separate permit must be obtained for each occurrence).
- *Off-Premises Farm Stand Signs*—To the extent allowed by the State, a grower who sells fresh fruits, vegetables or other agricultural crops on the same premises where such crops are grown may install a maximum of four (4) Off-Premises Farm Stand Signs for the purpose of directing motorists to the location where the crops are grown and offered for sale.

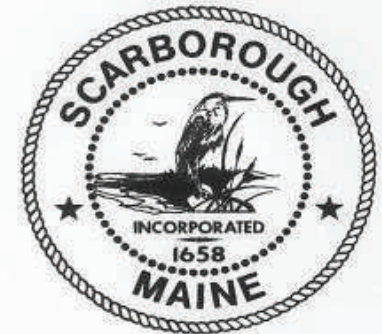

## Department of Planning - Sign Info

The purpose of regulating signs in Scarborough is to promote and protect the public health, welfare and safety of our Community by regulating existing and proposed signs of all types; to protect your property value while enhancing and protecting the physical appearance of our community, preserving the scenic and natural beauty and providing a more enjoyable and pleasing community; to reduce sign or advertising distractions and obstructions that may contribute to traffic accidents, reduce hazards that may be caused by signs overhanging or projecting over public right of way, provide more open space and curb the deterioration of natural beauty and community environment.

Before any new sign is erected or existing sign is moved or altered, an application accompanied by the appropriate fee must be submitted to Code Enforcement and a permit issued to the applicant by the Department. The following Table is Subsection E from Section XII of the Zoning Ordinance. Please refer to the complete Zoning Ordinance and this Section for more detailed information on all sign regulations.
